Tracy continued with his introduction, and informed the group that past president Pat Konov wasn't able to attend as she was attending her 50th high school reunion down in Maryland, a once in a lifetime event! Tracy then continued on to give moving tributes to Genevieve Coleman and Jordan Konov, husband of past president Pat Konov. Tracy was pleased to announce that "Jordan Konov has made the Thomas Rogers Society the beneficiary of a substantial endowment that will be used to honor a deserving student, in an annual scholarship fund, in Jordan's name." We held an extended moment of silence for all departed members.

Mary Brown presented the Secretary's report as presented in the Roster. A motion to accept was made by John Richardson, and seconded by Jeanne Erb.

John Richardson then presented the Genealogist's report, indicating that he had approved 45 new members since the last triennial meeting.

Nancy Frederick gave an update on the 6th and 7th generation project, and asked each family to continue to help and submit additional families to help towards completion of this project.

Tracy challenged the audience, and those not present, to "talk up" the society in order to work on increasing our current membership. As he had at the last triennial meeting, Tracy re-emphasized his belief in the importance of family cohesiveness, and that he would continue to stress "O'hana", which in Hawaiian means family. He handed out copies of the recent work tracing Thomas Rogers' ancestry within Europe. John Richardson suggested we look into placing a plaque near Thomas's birthplace.

Dear Thomas Rogers Society,


